- Measles (Rubeola)
- Mumps
- Rubella
- Varicella (chickenpox)
- Hepatitis B
- Tetanus, Diphtheria, and Pertussis (Tdap)
- Tuberculin test
 - Due annually
- Influenza
 - Due annually, prior to November 1st
